# **COMPLAINT**

Comes now the Plaintiffs, Tammy Bell and Cheryl Roe, and for their cause of action against the Defendants, West Memphis School District and West Memphis School District Board of Education, states:

# PARTIES, JURISDICTION, AND VENUE

- 1. This is an action brought pursuant to the Arkansas Freedom of Information Act of 1967 (herein "FOIA"), as amended, codified as Ark. Code. Ann. § 25-19-101 *et seq*.
- 2. Plaintiff Tammy Bell is an adult citizen of the State of Arkansas and a resident of Crittenden County. Plaintiff Cheryl Roe is an adult citizen of the State of Arkansas and a resident of Crittenden County. Plaintiffs bring this action as a matter of right under Arkansas Code Annotated § 25-19-107. Plaintiffs are taxpayers who reside in the West Memphis District of Crittenden County, and who pay taxes that support the West Memphis School District.

- 3. Defendant West Memphis School District is a school district organized pursuant to the laws of the State of Arkansas. The West Memphis Board of Education (sometimes referred to as "the Board") is the governing body of the West Memphis School District. The West Memphis Board of Education is tasked with complying with the open-meetings provisions of the Arkansas Freedom of Information Act ("FOIA"), codified at Ark Code Ann. § 25-19-106.
- 4. Jurisdiction and venue are appropriate in the Court pursuant to Ark. Code Ann. § 25-19-107(a).

## FACTUAL BACKGROUND

- 5. On or about April 18, 2023, the West Memphis Board of Education met for a regularly scheduled Board meeting. Board member Basil Joiner made a motion in the meeting to go into executive session for a personnel matter. After returning from the executive session, Mr. Joiner made a motion to terminate Superintendent Richard Atwill's contract effective immediately. The Board voted (4-3) in favor of firing Atwill, without explanation, and paying him \$350,000 as part of a severance package. (Exhibit A; Board Meeting Minutes)
- 6. That according to a news report, Board member Dr. Kimberly Wolfe was not told why Atwill's contract was terminated. Dr. Wolfe reportedly stated, "I have no idea. I don't know why. There was no explanation given."
- 7. That the Board then named Willie Rhodes as interim superintendent nearly a day after terminating Atwill's contract.
- 8. On or about May 31, 2023, the West Memphis School District announced that Dr. Terrence Brown was selected as the new superintendent after the Board conducted interviews. On June 6, 2023, the Board held a special meeting and unanimously approved Dr. Brown's contract.
  - 9. Plaintiffs were unaware that the Board interviewed any candidates for the position

because no notice was given to the public. A FOIA Request was submitted seeking all documentation related to these interviews. An email chain was obtained showing that the Board secretly interviewed four candidates for the superintendent position on May 24<sup>th</sup> and 25<sup>th</sup>. (Exhibit B). The candidates were Terrence Brown, Wyonia Scott, Toriano Green, and Rodriguez Broadnax.

- 10. No notice of these superintendent interviews was provided to the Plaintiffs, to the media, or the public pursuant to § 25-19-106.
- 11. Board member Dr. Kimberly Wolfe was apparently concerned that the Board violated FOIA by not giving notice of the interviews and reached out to an Arkansas School Boards Association attorney to ask about the open-meetings provisions of the AFOIA. (Exhibit C) According to Dr. Wolfe, "the meetings were not open to the public and the dates/times were not publicized." Dr. Wolfe did not participate in any of the interviews according to the emails identified in Exhibit C.
- 12. The Arkansas Freedom of Information Act states: "It is vital in a democratic society that the public business be performed in an open and public manner so that the electors shall be advised of the performance of public officials and of the decision that are reached in public activity and in making public policy. Toward that end, this [act] is adopted, making it possible for them, or their representatives to learn and report fully the activities of their public officials." As the United States Supreme Court has stated, "The basic purpose of FOIA is to ensure an informed citizenry, vital to the functioning of a democratic society, needed to check against corruption and to hold the governors accountable to the governed." *NLRB v. Robbins Tire Co., 437 U.S. 214, 242.*
- 13. Under FOIA, "except as otherwise specifically provided by law, all meetings, formal or informal, special or regular, of the governing bodies of all municipalities, counties,

townships, and school districts and all boards, bureaus, commissions, or organization of the State of Arkansas, except grand juries, supported wholly or in part by public funds or expending public funds, shall be public meetings." Ark. Code Ann § 25-19-106(b)(2).

- 14. Furthermore, FOIA requires that a governing body give notice of special or emergency meetings at least two hours in advance to media organizations that have requested notice in order that the public shall have representatives at the meeting. Ark. Code Ann. § 25-19-106(b)(2).
- 15. The interviews held by the Board in May 2023 violated FOIA in that no notice of the meetings were given to the public and the public was deprived of its right to observe the public portions of the meeting.
- 16. The Court should declare that the interviews on May 24<sup>th</sup> and 25<sup>th</sup> constitute illegal meetings under FOIA which were not public and for which no notice was given. The Court should further enjoin the Defendants from conducting public business in secret in the future.

## **Prayer for Relief**

WHEREFORE, the Plaintiffs pray that the Court grant the relief requested herein, that the Court hold a hearing on this matter and declare that the meetings held by the West Memphis Board of Education constituted an unlawful meeting under FOIA which was not public and for which no notice was given; that the Court enjoin the Defendants from conducting business out of the public view through secret meetings; for such other relief as is requested herein; for costs; for attorney's fees; and for such other relief as is just and proper.

# West Memphis Board of Education April 18, 2023 6:00 West Jr. High Minutes

The West Memphis Board of Education met at West Jr. High on Tuesday April 18, 2023 for their regular scheduled Board meeting. All board members were present.

Ms. Faulkner asked Reverend King to open the meeting with prayer.

Ms. Faulkner recognized all visitors to the meeting.

Ms. Faulkner asked to move and place items 2 and 11 after Old Business on the Agenda.

Mr. Joiner made a motion to table items 6 through 12. The motion was seconded by Mr. Hampton. The vote was as follows: Vote-Wolfe-no, Scarborough-no, Joiner-yes, Faulkner-yes, Thoman-no, Hampton-yes and Gray-yes. The motion passed with a vote of 4-yes votes and 3- no votes.

March

Mr. Joiner made a motion to approve paying April bills. The motion was seconded by Mrs. Gray. All in favor the motion passed.

Mr. Thomen made a motion to approve the Board Financial Report. The motion was seconded by Mrs. Wolf. The vote was Wolf-yes, Scarbrough-yes, Joiner-no, Faulkner-no, Thomen-yes, Hampton-no and Gray-no. The motion did not pass with a vote of 3 yes votes and 4 no votes.

Mrs. Gray made a motion that a Feasibility Study be done at West Jr. High and East Jr. High to determine the equitability of additional resources at both schools. The motion was made by Mr. Joiner. All in favor the motion passed.

On returning from the executive session Mr. Joiner made a motion to terminate Richard Atwills contract effective immediately. And to appoint Mr. Willie Rhodes as the interim Superintendent. Mr. Atwill will receive payment of his outstanding 3-year contract through June 30, 2025 along with payment for his benefits, maintain ownership of his district provided school vehicle. Mrs. Gray seconded the motion. The vote was

Mr. joiner then ask Mrs. Faulkner to direct the school attorney Brad Beavers to post the position with April 19, 2023 being the first day for 14 days. Mr. Beavers told Mrs. Faulkner that he would not be available to do that. Mr. Joiner then ask her to tell the West Memphis Human Resource Officer to post the position. Also, to contact the Great Rivers Service Coop and ask them to screen all applicants for eligibility. They would be allowed up to \$12,000 for any expenses they accrue.
